Beil distributed and discussed three handouts. Dane County Health and Human Needs Committee approved the addition to the 2015-2017 Legislative Agenda proposed by this Committee and approved by the AAA Board. The County Board is expected to vote on this by January 2015. The new Congressional members will take office in January, and two issues high on their agenda will include Medicare and Social Security changes.

3. WISCONSIN AGING & ADVOCACY NETWORK

Thompson reported WAAN will be discussing a proposal from Visitable Wisconsin to endorse the idea of requiring new home construction to follow minimum accessibility standards.

4. CHAIR & STAFF REPORTS

Velasquez submitted a Medicare Improvements for Patients and Providers Act (MIPPA) grant application to DHS. The grant is awarded every three years to ten to 11 areas throughout the state. Funding would go toward outreach and training. If awarded, this grant will fund a ten-hour per week staff position. The outreach focus will be on low-income and minority seniors living in Dane County.

Batterman and Velasquez met recently with Care Wisconsin CEO Karen Musser. Two areas of concern reported by Focal Points include communication with case management staff and reimbursement of nutrition meals for Care Wisconsin clients. Musser will discuss the concerns with her staff and reconnect with Batterman and Velasquez. Starting in November, ADRC staff began enrolling seniors in partnership programs—which include Care Wisconsin and iCare in Dane County.

Batterman is reformatting and updating the AAA website to make it more user-friendly.

Batterman invited Committee members to attend the next AAA Board meeting (Monday, 1 December, 3:45 pm). Bureau of Aging & Disability/Office on Aging Supervisor Jim Schmidlkofer will be honored in advance of his retirement.
