RE: Approve Endowment Distribution Request from the Madison Community Foundation for Collaborative Friends Grant Awards

I am writing to respectfully request the Park Commission's approval for two related actions concerning the Friends of Dane County Parks Endowment held at the Madison Community Foundation (MCF):

1. Approval of Collaborative Friends Grant Awards

The Friends Grant Program remains a valuable tool for empowering community groups to support the stewardship and enhancement of Dane County Parks.

I request the Commission's approval of the Collaborative Friends Grant awards, as recommended by the review committee and outlined in the attached table.

The program is titled the *Collaborative* Friends Grant Program in recognition of the Foundation for Dane County Parks, which plays a lead role in fundraising to grow the endowment. The Foundation also has representation on the grant review committee.

The total proposed funding for this year's grants includes \$6,000 from the Dane County Parks operating budget, with the remainder to be funded through an endowment distribution, contingent upon approval of the request below.

2. Authorization to Request MCF Endowment Distribution

I am also requesting authorization from the Commission to request a \$9,043 distribution from the Friends of Dane County Parks Endowment at MCF to fund the balance of this year's grant awards. Combined with the county contribution, this distribution will enable us to fully fund the proposed projects submitted by our Friends groups, so long as the projects met grant eligibility criteria.

Additional endowment funds remain available, and I anticipate submitting a second distribution request later this calendar year.

2025 Spring Friends Grant Application Summary

The Foundation for Dane County Parks and Dane County Parks collaborative grant program is open to Dane County Parks Friend Groups and partner organizations to lead educational programs, implement small projects, and purchase equipment for volunteer workdays. This collaborative grant program can fund a full or partial project/program between \$250-\$2,000. This year's grant application period ran from February 20, 2025 to March 24, 2025.
