HOME CONTRACT AMENDMENT REQUEST FROM THE WI PARTNERSHIP FOR HOUSING DEVELOPMENT

Policy Analysis Statement:

Brief Description of Proposal -

Due to new building requirements and unforeseen construction costs, the WPHD is requesting to move \$100,000 from it's 2020 HOME award to it's 2019 award, bringing the 2019 award to \$400,000 which will be used towards the development of 2 supportive housing units for low-income families in Stoughton. The proposal would reduce the WPHD 2020 award from \$222,192 to \$122,192 and change number of affordable units to be developed from 2 to 1.

Current Policy or Practice -

The proposed amendment would trigger a substantial amendment to the 2019 Annual Action Plan, which requires Board approval.

Impact of Adopting Proposal -

Amending the project by shifting HOME funds already awarded to the WPHD for a 2020 PY project will allow the 2019 project to move forward, while reducing the 2020 expected units to developed from 2 to 1. There would be no overall fiscal effect for the County.
