



Beginning at the East 1/4 Corner of said Section 5; thence S 00°47′11 W along the east line of the SE 1/4 of said Section 5, 354.39 feet; thence S 46°29′26″ E, 556.02 feet; thence S 63°08′42″ W, 461.10 feet to said east line; thence S 00°47′11″ W along said east line, 489.31 feet; thence N 36°28′22″ W, 1,102.83 feet; thence N 36°26′21″ W, 685.91 feet to the north line of the NE 1/4 of the SE 1/4 of Section 5; thence S 89°47′34″ E along
