Richard Diehl - Town of Vienna, Section 22

A-2 Zoning CUP# 2095

On July 11, 2018 I conducted a site inspection of the salvage yard and the conditions of the CUP are in compliance. This is a very active site with various items recycled and disposed of on an hourly basis.



John Rowley - Town of Verona, Section 31

A-2 Zoning CUP# 419

On July 11, 2018 I conducted a site inspection of the salvage yard. Salvage items on site include various cars, trucks and farm machinery. Little to no change from previous years.



Steve Suter - Town of Blooming Grove, Section 24

A-2 Zoning CUP# 1258

On July 11, 2018 I met with Steve Suter and conducted a site inspection of the salvage yard. Salvage items on site include various motorcycle and snowmobile items and items are within the approved salvage yard limits. No change from the previous year.



Michael Cutrano - Town of Christiana, Section 2
M-1 Zoning CUP# 915

On July 11, 2018 I met with Mike Cutrano and conducted a site inspection of the salvage yard. Overall, the number of salvage vehicles has decreased in size and the overall operations are being diminished. Vehicles are parked in an orderly manner along USH 12/18.



Thayer Every - Town of Dunkirk, Section 30
A-2(2) Zoning CUP# 2366

On July 11, 2018 I conducted a site inspection of the salvage yard. Various vehicles, metals and tires on site with dumpsters.



Dave Toothman - Town of Rutland, Section 20
A-2(2) Zoning CUP# 2366

On July 11, 2018 I conducted a site inspection of the salvage yard. Items include various recyclable metals and misc. building materials on site. This site was permitted earlier in the year.



John Mullarkey - Town of Oregon, Section 15
A-2(4) Zoning, CUP# 663

On July 11, 2018, I conducted a site inspection of the salvage yard. Salvage items on site include various vintage cars, trucks and farm machinery. Items are within the limits established, but misc. garbage and debris are scattered about the property. I talked with the owner to clean up and dispose of the garbage within the next few weeks. This site appears to not process salvage items, but remove whole vehicles here and there.



Brian Outhouse - Town of Perry, Section 24
A-2 Zoning, CUP# 939

On July 11, 2018 I conducted a site inspection of the salvage yard. Salvage items on site include medium and heavy-duty trucks and items are within the approved salvage yard limits. This site is very full and a lot of activity going in and out.
