McCarthy Master Plan

James provided an overview of the history and draft recommendations being proposed in the McCarthy Youth and Conservation Park Master Plan. The primary of purpose of the park is to provide youth with a place to learn about nature. The Ho-Chunk Nation and UW Madison are interested in creating a series of educational exhibits in the park to increase public awareness of Wisconsin's Native American culture. Other draft recommendations include further development of trails, a new shelter and playground area and consideration of a regional sports complex facility in the Cottage Grove/Sun Prairie region.
