AUTHORIZING RECLASSIFICATION OF VACANT LEAD WEAPONS SCREENING POSITION TO A WEAPONS SCREEING ATTENDENT POSITION IN THE SHERIFF'S OFFICE

Policy Analysis Statement:

Brief Description of Proposal -

The Dane County Sheriff's Office, Support Services Division, requests reclassification of position #2225, Lead Weapons Screening Attendant (G8 pay range), currently vacant, to a Weapons Screening Attendant (G 3-6 pay range). The Sheriff's Office currently utilizes a different organizational structure and the position no longer meets the criteria to be classified as a lead worker position.

Current Policy or Practice -

Reclassification of positions requires County Board approval.

Impact of Adopting Proposal -

This resolution will make it possible to reclassify the Lead Weapons Screener position to a Weapon Screener Attendant position. Dane County Courthouse weapon screening operations are important for the safety and security of the Courthouse for the individuals who work there and those who visit.
