Policy Analysis Statement:

Brief Description of Proposal -

The US Department Transportation and Wisconsin Department of Transportation, Bureau of Transportation Safety are making funds available for continued participation in a Critical Traffic Investigation and Prosecution Collaboration Project. Funding is provided to improve traffic safety in Wisconsin through a multi-jurisdictional collaborative effort comprised of representatives from Dane County Sheriff's Office, Ma dison Police Department, Wisconsin State Patrol, Dane County Coroner's Office, a dedicated prosecutor and victim services. This unit will investigate and prosecute cases involving impaired/reckless/negligent driving injuries/fatalities and any other impaired driving offenses.

Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board.

Impact of Adopting Proposal -

A dedicated prosecution team, as specified above, provides Dane County with a uniform protocol for investigating and prosecuting crashes involving criminal charges. Since the inception of the Dedicated Prosecutor Project, Dane County has provided complete investigation from start to finish on crashes involving criminal charges. These crashed are considered high priority investigated using a team approach which results in drivers being held accountable for reckless behavior, ultimately making Dane County roads safer.
