4 **AUTHORIZING AN AGREEMENT TO ACCEPT HIGHWAY SAFETY GRANT FUNDS**  
5 **FOR AN ANTI-TEXTING/INATTENTIVE DRIVING ENFORCEMENT CAMPAIGN**  
6 **GRANT NUMBER FG-2014-DANE CO-2453**

8 The Department of Transportation, Bureau of Transportation Safety, State of Wisconsin, is  
9 making funds available May through September 2014, for participation in an 2014 Anti-  
10 Texting/Inattentive Driving Enforcement Project, Grant Number FG-2014-DANE CO-2453. The  
11 goal of the federally funded enforcement project is to decrease the number of person's texting  
12 while driving and ultimately reduce traffic crashes. Texting is a leading cause of crashes related  
13 to inattentive driving and with the beltline highway undergoing a large construction project,  
14 additional enforcement of texting/distractive driving will minimize injury and loss of life.  
15

16 **NOW, THEREFORE, BE IT RESOLVED** that the Sheriff's Office is hereby authorized to  
17 accept \$10,000 from the Department of Transportation, Bureau of Transportation Safety, for the  
18 Anti-Texting/Inattentive Driving Enforcement Grant, targeting the beltline highway.  
19

20 **BE IT FURTHER RESOLVED** that \$10,000 is set up as additional revenue in the  
21 Sheriff's Office, Field Services Anti-Texting/Inattentive Driving Enforcement Grant revenue  
22 account (SHRFFLD-New) and to be credited to the General Fund.

24 **BE IT FURTHER RESOLVED** that \$10,000 is transferred from the General Fund to the  
25 following accounts:

Overtime-Texting/Inattentive (SHRFFLD-New)	\$8,100
Social Security (SHRFFLD-10108)	\$600
Retirement Fund (SHRFFLD-10099)	\$1,000
Workers Compensation (SHRFFLD-10189)	<u>\$300</u>
