Brief Description of Proposal -

Purchase property from the Town of Blooming Grove for county operations. The Town will lease one of the buildings from the County for the next 12 years (or less, if the Town dissolves before then).

Funds for the purchase are included in the Executive's 2017 budget. Closing would occur in 2017.
