- The office started with one bilingual/ bicultural Social Worker. Since then, another bilingual/bicultural Social Worker has joined IAO.





### Definitions

#### **Immigrants**

 Someone who makes the decision to leave their country to permanently move to another country.

#### Migrants

Someone who moves from place to place, typically for economic reasons.

#### Refugees

 Someone who is forced to flee their home because of war, violence, and persecution.

#### Asylum seekers

 Someone seeking international protection from dangers in their home country but claim for refuge has not been determined yet.


#### Services we <u>can</u> assist with:


- Immigration legal resources
- Assistance with filing fees for DHS
- Assist with passport process
- Sign a U-Visa Certificate if connected to DCDHS
- Assistance with repatriation process
- Notarize documents

#### Services we <u>cannot</u> assist with:

- Provide legal advice
- Pay private attorney service fees
- Fix documents from home countries
- Cannot initiate the application for U-Visa, application must be sent by attorneys.
- Do not have funds to cover funeral and repatriation expenses.

### ICE arrests 83 people in Wisconsin over 4-day operation

MADISON, Wis. — U.S. Immigration and Customs Enforcement has arrested 83 people over the course of a four-day operation, according to a news release from the agency.

Arrests were made in 14 Wisconsin counties. Twenty of the arrests were made in Dane County and 15 were made in Milwaukee County.

The people arrested were from eight countries, including Colombia, Guatemala, Honduras, Mexico, Nicaragua, Russia, Thailand and Vietnam. Of those arrested, 77 were

#### ABOUT THE FUND:

Latinx are the largest non-white racial/ethnic group in Dane County, WI (~35,000), close to 70% live in Madison and Fitchburg. This community is uniquely vulnerable to the COVID-19 crisis: 70% are renters, 68% live in multi-unit dwellings, 34% fall below the poverty line, and almost two out of every five work in the service industry in Dane County. Moreover, nearly 50% of Latinx lack healthcare insurance coverage in Wisconsin

This is why we are coming forward now, together, as a consortium of Latinx serving organizations, to announce the creation of a Latinx Consortium for Action Relief Fund that specifically focuses on the needs of the Latinx community. 
### Advocacy

#### Latinx Support Network (LaSup):

Network of social service providers that share information/ resources and find solutions to community needs

#### Latinx Health Council (LHC)
