ACCEPTING STATE OF WISCONSIN GRANT FUNDS AND AMENDING 2019 CONTRACTS WITH AIDS RESOURCE CENTER OF WISCONSIN AND JOURNEY MENTAL HEALTH CENTER DCDHS – ACS DIVISION

#### **Policy Analysis Statement:**

### Brief Description of Proposal -

The Department of Justice has awarded Residential Substance Abuse and Treatment Program grant funds to Dane County to link jail inmates with treatment for opioid dependence on opioids. This grant has been available to DCDHS since 2013. This award will allow DCDHS to continue contracting with the AIDS Resource Center of WI (ARC-W) for outreach workers to be in the jail meeting directly with inmates who have been incarcerated for an opiate-related offense or have been identified as having gone through withdrawal from opiates while incarcerated at the Dane County Jail.

### Current Policy or Practice -

Budget changes require County Board approval.

### Impact of Adopting Proposal -

If they are willing, the outreach workers will connect a person with staff from Journey Mental Health Center who can begin providing treatment services while incarcerated. Treatment continues after the person is released from the Dane County Jail. These services include case management and medication assisted treatment for substance use disorder. Whenever possible, inmates will have the opportunity to receive an initial injection of Vivitrol immediately prior to their release. Vivitrol is the injectable form of naltrexone, an opioid antagonist that mutes the effects of opioid use by blocking opioid receptors in the brain. Journey Mental Health Center provides treatment in the community for an individual while helping them find a more permanent provider that is covered by an individual's health insurance. Journey will continue to treat those who do not have health insurance.
