RE: Legislative Update

The final days of the Legislative Session are upon us and expect the unexpected. The Standing Committees in each Chamber have been busy with public hearings and executive sessions to pass bills in time for floor action. The Assembly is scheduled for final floor action on Feb. 9, 16 and 18 and the Senate Feb. 9, 16 and March 15.

The Speaker's Heroin, Mental Health and Alzheimer/Dementia legislative packages are moving through the Legislature.

Amidst all this flurry of activity, AB 563/SB 479 (Towns Withdraw Dane County Zoning) passed the Assembly on Feb. 9<sup>th</sup> and the Senate on Feb. 16<sup>th</sup>.

After the Legislature adjourns, Legislative Council study committees will be created to research, review and make recommendations on a variety of topics. The topics will be selected towards the end of Spring.

In early April, the State Department of Health Services will hold another hearing on Family Care.
