Brief Description of Proposal -

This resolution renews the interagency agreement between the Dane County District Attorney's Office and the UW Population Health Institute for technical assistance with the Opiate Diversion Program for Treatment Alternatives and Diversion Project. Project year three expired on December 31, 2024 and this resolution simply renews the project and releases funding for year four of the five-year grant project.

Current Policy or Practice -

\$30,000 is allocated annually via the TAD grant. There is no change to the cost or services year-over-year but this is year 4 of 5 years funded (each yr is funded at \$30,000/yr)--an annual addendum must be submitted for each year.

Impact of Adopting Proposal -

This resolution will ensure that no interruption occurs in year four of the interagency agreement. It satisfies the requirement for submission of an annual addendum allocating the \$30,000 from the TAD grant for the current year's work.
