### **Immigrants: Who are they?**

**"Foreign born**" and "**immigrant**" are used interchangeably and refer to persons with no U.S. citizenship at birth. This population includes naturalized citizens, lawful permanent residents, refugees and asylees, persons on certain temporary visas, and the unauthorized

43.7 million immigrants ---13.5 percent of the total U.S. population

Immigrants and their U.S.born children number approximately 86.4 million people --- 27 percent of the overall U.S. population

### Important terms

#### Refugee

- A person who has been forced to leave their country in order to escape war, persecution or natural disaster.
- Refugee Status is determined abroad
- Receive resettlement aid and other benefits

#### Asylee

- A person who is seeking or has been granted political asylum.
- Asylee status is granted AFTER a person arrives in the United States

#### Guest worker

Temporary work permit, usually in certain industries, person must return

## Documentation status: US Citizen

- \* A person born in the United States or its territories. Example: Any person born in Wisconsin, or any person born in Puerto Rico.
- \* **A person born to a US citizen:** Any person born outside the United States or its territories whose mother or father is a US citizen. Example: Born in France to US soldier, born in Costa Rica to a US citizen
- Naturalized citizen: A person born outside the United States or its territories that earns the rights and privileges of US citizenship. (Legal process)



Documentation status: Non-US Citizen

- **Resident:** lawful resident aka green card holder
  - Conditional residence
  - Permanent residence
- Visa holder: Many types of visas. Different visas will afford you different rights and different stay times in the USA
- Undocumented immigrant: A person that is residing in the US without legal documentation status or after that documentation has expired.

# What is Deferred Action for Childhood Arrivals (DACA)?


- 2012 Executive Order allowing certain people who came to the United States as children and meet several guidelines to request consideration of deferred action for a period of two years, subject to renewal.
- Eligible for work authorization.
- Eligible for Driver's license
- Deferred action means deferred removal action for a certain period of time.
- Deferred action does not provide lawful status.
- DACA recipients cannot apply for governmental assistance.
- Currently DACA is in state of limbo.

- Divided families that do not know when they will be reunited.
- It is not clear what will happen to immigration applications currently pending with USCIS.
- A general fear of ICE raids and deportation

### Dane County's response to increasing needs for immigration services

#### \* Creation of an Immigration Assistance Fund

The Dane County Executive and Dane County Board of Supervisors committed to \$150,000 from county funding. The Madison Community Foundation is administering the fund in collaboration of community partners.

#### \* Hire of an Immigration Affairs Specialist

Provides outreach and resources to immigrants, and refugee communities in Dane County in order to support integration through coordination of county services.


