AMENDING CHAPTER 15 OF THE DANE COUNTY CODE OF ORDINANCES, INCREASING CONDEMNATION COMMISSIONERS HOURLY RATE

**Policy Analysis Statement:**

Brief Description of Proposal -  
This amendment increases the hourly rate of condemnation commissioners from \$40 per hour to \$80 per hour.

Current Policy or Practice -  
They receive \$40 per hour.

Impact of Adopting Proposal -  
No county fiscal impact. Under Wis. Stat. 32.08(4), all compensation and expenses for the condemnation commissioners are paid by the condemnor on order approved by the circuit judge. Specifically, the law further provides that after an award is finalized by the commission, the commissioners are to file with the clerk of court a sworn voucher for the compensation due each member that the court approves and the condemnor pays.
