AUTHORIZING A CONTRACT ADDENDUM BETWEEN THE ALLIANT ENERGY CENTER OF DANE COUNTY AND WISCONSIN HORSE COUNCIL

Policy Analysis Statement:

Brief Description of Proposal -

This proposal approves a contract addendum between the Alliant Energy Center and the Wisconsin Horse Council to address the cancellation of its 2020 and 2021 Midwest Horse Fair events due to the COVID-19 pandemic. This addendum adds the 2034 and 2035 Midwest Horse Fair dates to the current contract.

Current Policy or Practice -

Section 28.05(6) of the Dane County Ordinances requires leases greater than \$100,000 at the Alliant Energy Center be approved by the County Board and County Executive.

Impact of Adopting Proposal -

Adoption of this proposal approves a contract addendum between the Alliant Energy Center and the Wisconsin Horse Council to extend the current contract to include the 2034 and 2035 Midwest Horse Fair dates.
