## 1. Schumacher Farm Project Bids

*RIPP and Hicklin indicated that bids for Schumacher Farm capital projects had greatly exceeded expectations and budgets. PW&T has requested that bidders provide cost breakouts for project components to assist in analysis. Friends of Schumacher Farm have scheduled a meeting with PW&T staff to determine next steps.*

## 2. Cave of the Mounds - Brigham Trail Easement Donation

*Zimmermann explained that this spur trail has already been built by Parks on private lands owned by Ebenezer Brigham, LLC. The trail easement document has been reviewed by Corporation Counsel and will be taken up by the PW&T Committee for approval on 6/20/17.*

## 3. City of Verona - Lincoln Street Channel Rehabilitation Phase II

*James summarized this stream channel restoration project being undertaken by the City of Verona that encompasses lands owned by the Parks Division. The stream feeds into Badger Mill Creek. A temporary limited easement to the City has been reviewed by Corporation Counsel and will be taken up by the PW&T Committee for approval on 6/20/17.*

## 4. Quit Claim Deed to Monicken at the Falk Wells Sugar River Wildlife Area

*Hicklin explained that residential property owners in Paoli have a long-standing encroachment on park land purchased from the Bruce Company. A resolution will be introduced 6/15/17 to approve a quit claim deed of approximately 1/5 acre to the Monickens for \$6,000 to resolve this title issue.*

## 5. Goodland Park Beach Water Quality Improvement Projects

*James explained that this beach improvement project being constructed now at Goodland Park is similar to the effective beach project undertaken last year at Mendota Park.*

## 6. 2018 Budget

*Hicklin explained that the 2018 budget process is underway. The Commission discussed potential impacts of County capital projects and staff changes on this process.*

**H. Announcements**

*Kevin Connor's Retirement* – LUNNEY announced that Kevin Connors formally announced his retirement, his last day being 7/21/17. Hicklin will be named Acting Director of LWRD, and John Reimer, Acting Deputy Director. A party is being planned for Thursday, July 20th at Fen Oak to celebrate Kevin's service and accomplishments.

*Joint Meeting of Natural Resource Committees* – LUNNEY indicated that Lakes & Watershed Commission had hosted this joint meeting on 6/8/17 and urged Park Commission members to participate in future such joint meetings. LUNNEY recommended that the Park Commission adopt an "Equity and Inclusion Commitment Statement" similar to the one taken up by the Lakes & Watershed Commission.

*Marketing Outreach* – Hicklin explained that an "Acting Class" status is being implemented for Susan Sanford to assume some of the duties of the Marketing and Outreach Coordinator during the extended absence of Erika Hotchkiss. Susan has already been most helpful in cross posting various volunteer opportunities.

*Lower Yahara River Trail* – LUNNEY indicated that a LYRT "Preview" and fund-raising event is planned at the Lussier Family Heritage Center on September 20th to include a VIP event, trail tour and staff presentation. The soft opening of the trail is anticipated by September 1st. A larger "Grand Opening" event is planned for June 2018, and event sponsors are being secured.

*Stewart Lake Diving Accident* – Marsh mentioned the recent incident which resulted in injury to a young man that hit his head while diving from a cliff into Stewart Lake. Few details are available from the Dane County Sheriff.
