Authorizing Purchase of Service Agreement between Dane County and API Outsourcing, Inc. for Tax and Assessment Printing

## **Policy Analysis Statement:**

#### Brief Description of Proposal -

Following receipt and scoring of the proposals for printing needs for tax bills, notices, and tax and assessment rolls, staff recommended a Purchase of Service Agreement be awarded to API Outsourcing, Inc. This resolution allows API Outsourcing to be awarded a five-year contract not to exceed \$50,000 annually. This agreement is covered by funds budgeted annually.

# Current Policy or Practice -

The Records & Support Division of the Planning & Development Dept. contracts out for tax and assessment printing needs. Associated costs are included in the annual budget.

### Impact of Adopting Proposal -
