

Dear Zoning Committee Members,

You may be considering whether the .2 PPV limit recently set by the Deerfield Town Board is going to protect the historic St. Paul's Liberty Lutheran Church from further damage due to Oak Park Quarry blasting. Studies show .2 is not enough. The work of internationally known blasting expert Dr. Partha Das Sharma, shows .08 PPV is the necessary limit to protect buildings such as the historic church. .08 PPV was the limit desired by Dr. Roxanne Engelstad, but she recommended .12 PPV largely because she thought it would be more palatable for the Town Board. Most unfortunately, the Town Board approved .2 PPV, largely because it felt this limit would be more legally justifiable. I was not on the Board when it passed the .2 limit. A limit that is more legally justifiable is useless in practice if it does not stop the damage, and .2 PPV, even coupled with a corresponding frequency limit of 20 Hertz (which is stricter than our current limit of 14 Hertz) will not protect this historic building from further damage.
