D. Presentation

Presentation on the State Debt Collection Program

Esqueda and Municipal Judge Todd Meurer presented. Esqueda explained that the state debt collection program at the Wisconsin Department Of Revenue (DOR) was expanded to allow the court to collect unpaid court obligations under this program. Esqueda explained that currently the County uses a private collection agency, and informed the Committee about the incentives that the County pays to the private agency. Esqueda recommended that the County move from the private agency to the State Debt Collection Program at the DOR, and presented the committee with a draft resolution authorizing the switch (see attached document).

Meurer described his experience using the State Debt Collection Program and the financial benefits that resulted to his various municipalities. Meurer provided more detail about the State Debt Collection Program, and explained why the program is successful.

Committee members discussed the use of driver license suspensions, and how the transfer between the private agency to the State Debt Collection program would occur. Committee members also discussed what information should be included in the proposed resolution.
