C. Action Items

D. Presentations

- Joe Parisi, Dane County Executive, and Lynn Green, Dane County Human Services Director, discussed homelessness and housing, meeting basic needs of County residents, transitioning to Family Care by 2018, community restorative court pilots, pressures in child protective services due to increased referrals, foster parent recruiting especially for teens, and expanding the Building Bridges school based mental health teams. They stressed the importance of getting people connected to the correct services for which they are eligible. The 2016 budget maintained everything in sensitive crime areas. Jail re-entry positions were added as well as a mental health Ombudsman. 2017 budget guidelines are to maintain status quo. They encouraged members to let them know what their challenges are and whether there's any programming that doesn't meet today's needs where funds could possibly be diverted to meet current needs. Parisi explained the difference between operating and capital funds and noted that the state imposes limits on operating dollars. Capital dollars cannot be used for operating expenses and vice versa. Thornley-Parisi stressed the importance of sexual assault becoming more integrated into system discussions/data gathering. Murray suggested that the planned mapping project will identify gaps and programming that might be needed.
- 2. Lynn Green, Dane County Human Services Director: See Item #1.
- 3. Bail Hearings Marlys Howe and DA office reps: DA Ozanne explained the newly amended Dane County Bail Hearing rule that would reduce precharging incarceration time. The DA's Office feels it doesn't give adequate opportunity to gather accurate information in order for the DA's office to connect with victims. Another potential unintended consequence is that every charge will be put in CCAP, regardless if the DA decides to file charges, which may affect housing and employment prospects. DA Ozanne requested that the judges reconsider the rule and that they consider input from others who provide services to victims of sensitive crimes.
