Dear Members of the City-County Liaison Committee:

I am a member of the City of Madison's Women's Initiative Committee (WIC). The purpose of this email is to ask you to assist WIC in the goal of getting domestic abuse intervention materials in every one of the restrooms in the CCB in hopes of assisting victims of domestic violence. In explanation, the Women's Initiatives Committee is contacting all City building supervisors in order that we may achieve the goal of getting these domestic abuse intervention materials in the restrooms of every one of the City's buildings. We have already begun this process in the MMB, the Monona Terrace, and all branches of Madison Public Library. Obviously, each city agency has its own protocol for such decisions. We have been told by the City's Attorney's Office that you are the contact for those areas in the CCB. We are requesting that you assist us by discussing this possibility with the CCB building supervisor and that we be granted approval to post these materials. To be clear, WIC members will also take on the responsibility of replenishing these materials.

In essence, we are looking for permanent placement of posters that address domestic abuse in every restroom in the CCB. These materials are from Domestic Abuse Intervention Services (DIAS) and are similar to information one would see in many restrooms of health care facilities in Madison. We have the posters in both Spanish and English. They offer contact information and tear-off slips that give DAIS contact information for victims of domestic abuse. It is statistically proven that public restrooms are often the only place where victims of domestic violence are allotted privacy from their controlling abuser. This is very reason that we are asking to post the materials in these locations.

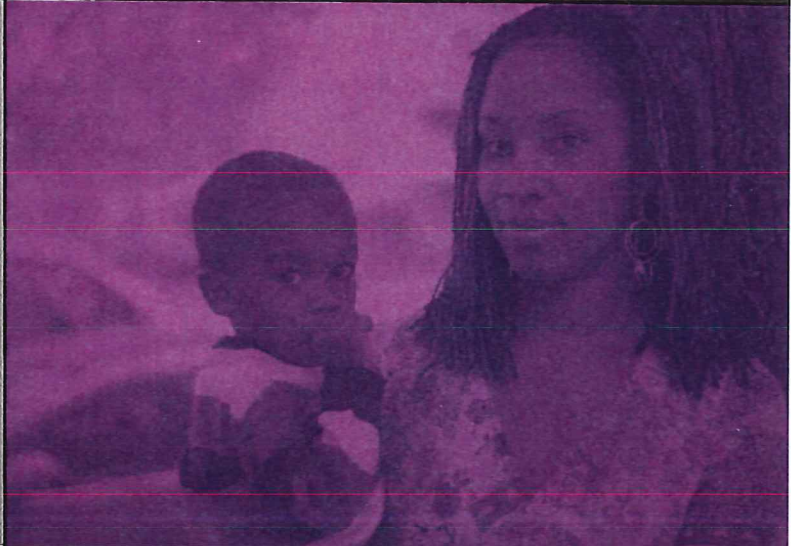
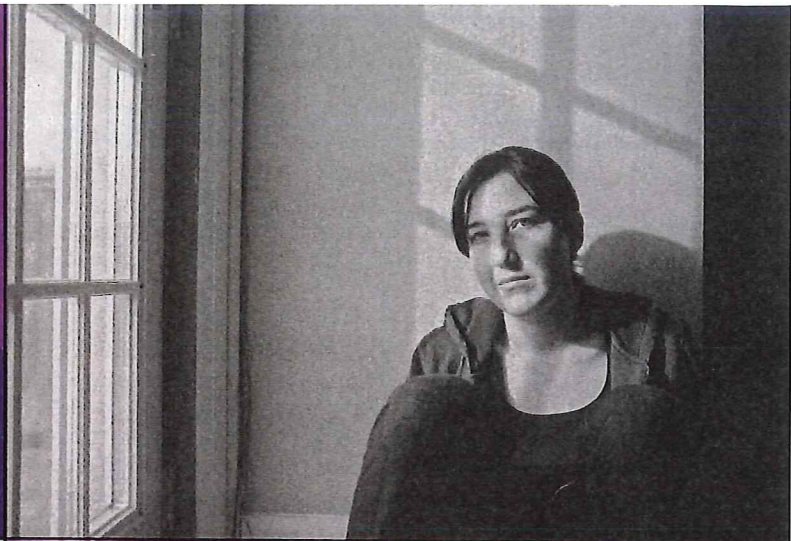
According to the National Coalition Against Domestic Violence, 20 people per minute are physically abused by their partner in the United States. The physical and emotional abuse victims experience directly impacts the workplace through economic issues and safety concerns. It is important that the City of Madison provides resources that enable their employees to break this cycle of violence. These resource flyers provide a safe and confidential way for individuals to seek assistance.
