

2023 Proposed Fee Changes

Dane County Parks is proposing to keep the majority of permit, shelter and camping fees the same for 2023. The last fee increases were pre-COVID, most increases were five (5) years ago or more. Fee history from the last 10 years is included for reference.

Dane County Parks intentionally kept fees stable throughout the uncertainty of the pandemic, knowing that Parks provided much needed recreational opportunities, physical and mental health benefits. However, the cost to maintain these facilities is increasing. Dane County Parks is proposing to raise a few of the permit fees for 2023.

Proposed changes include a fee increase for two cooperative permits: lake access and dog, an increase in the mountain bike trail permit, a new discount for veterans and military members, a new application fee for special event permit requests and an overhaul for fee-based recurring programs that use Dane County parkland as their primary meeting location.

Dane County Parks offers financial assistance to Dane County residents with financial limitations that prevent them from purchasing a permit.

These proposed fees were brought before Park Commission to solicit initial feedback on Wednesday, August 11, 2022. The public hearing will be held Wednesday, September 14, 2022. Details on how to attend the public hearing or provide comment are at the end of this document.

Cooperative Lake Access Permit – a partnership between the Cities of Madison and Monona and Dane County

The last increase for this cooperative permit was in 2018. Daily and annual lake access permit fees must comply with NR1.90 Public Access Policy for Waterways, which limits fees based on a specific formula. Per this policy, Dane County Parks is allowed to charge up to \$95 for an annual permit. The 2023 proposed fee is nearly half of the allowable amount.

Cooperative Dog Park Permit – a partnership between the Cities of Madison, Middleton, Sun Prairie and Dane County

The last increase for this cooperative permit was in 2018. Dane County Parks opened the Anderson Farm Dog Park this year and the 2023 capital budget request includes funding to start phasing in improvements, such as vault toilets (currently portable units), accessibility improvements at entrance gates, shade structures, trail improvements, etc.

Mountain Bike Trail Permit

Veteran and Military Members Discount

Offer a discounted rate for veterans and military members at the same rate as seniors and disabled persons, for all of the same types of permits currently offered at these rates: dog, lake access, cross-county ski, horse trail, mountain bike trail, and campsite reservations. Proof required. Proof of veteran status is a DD214 or VA ID, WI Driver's License with Veteran Identifier, or a membership card in American Legion or VFW; proof of military service is current orders or military ID.

New Application Fee for Special Event Permit Requests

Add a \$25 application fee for all special event permit requests. This will be a deposit for the \$75 special event permit, not in addition to the existing special event permit fee. It will be due at the time of application. Once the event is approved, the remaining \$50 for the special event permit will be assessed. In addition to the special event permit fee, additional fees are determined based on an event's specific requests, frequently added fees include: vending permits, alcohol permits and shelter reservations.

Special event permits are required for publically advertised events, for events that charge a fee to participate, for events that request to do things outside of regular allowable activities, and for events that sell merchandise, food or alcohol.

Many special event permit requests are submitted and then are later cancelled because the requestor changes their mind or does not communicate with staff after the event was approved. These events take a lot of time to prepare,

approve, communicate on, and keep track of administratively. The facilities are held for them at time of application, so they're unavailable for other users to reserve in the interim. If the applicant decides not to move forward with the event, the application fee will not be refunded.

This special event permit application fee will not apply for Friends and Partner Groups special event permit requests. All fees will continue to be waived for these groups.

Fee-Based Recurring Program Permit

Fee-based recurring programs are publically advertised programs that charge a participant fee (either per class or per session), meet more than one time, and are advertising their primary meeting location as a Dane County Park. These include: instructional courses, homeschool groups, preschool groups, fitness classes, etc. A typical school field trip does not fit into this category and should continue to reserve facilities through the standard reservation process.

These programs currently pay one \$75 special event permit fee, per location, per calendar year. If the group is not reserving a shelter, there are no additional fees. Most of these groups still use shelters if they are not reserved by another group, but choose not reserve them for exclusive use. Some of these groups meet weekly, some several times a week, most meet year round.

These groups are charging their participants, in some cases significant fees, while paying Dane County Parks \$75 to use a park as their home base for an entire calendar year. This type of programmatic park use has grown significantly over the last several years and Dane County Parks needs to adjust accordingly. Fitting these groups into the existing special event permit system is relatively new and it does not accurately charge for the amount of parkland use and services provided to these groups.

The proposed fee structure will switch recurring fee-based programs from an annual special event permit to three session permits:

- Winter/Spring (January May)
- Summer (June August)
- Fall (September December)

The proposed fee structure for recurring programs levels has fee tiers based on participant numbers. In addition to these tiered fees, the group will pay a \$25 application fee per session.

^{*}Participant #s are calculated on a total number basis, for example if a program runs 1 time per week over 7 weeks and there are 10 participants each time, the number of participants is 70, even if it is the same participants attending each weekly program.

This recurring fee-based program permit fee will not apply for Friends and Partner Groups permit requests. All fees will continue to be waived for these groups.

New Permit Level for Commercial Lake Access Users

The WDNR has had many requests regarding commercial use of boat launches and whether separate/different fees can be charged. Their legal opinion is that municipalities cannot charge specifically for commercial use. Dane County Parks is no longer pursuing this new lake access permit level for 2023.

Public Hearing Regarding Proposed 2023 Park Fee Increases
