The Youth Commission will host one annual event based on Youth Assessment Data; first topic is youth-identified concerns about gun access. Event may include a data presentation and expert panel answering pre-submitted questions.

Potential presenters: law enforcement, mental health, violence prevention staff, hunter education, Dane County Parks, Focused Interruption.
