Dear Members of the ZLR Committee,

I am writing to express my opposition to petition file 12275, which proposes rezoning the parcel at the Patton Road and Highway V intersection from Farmland Preservation to Heavy Commercial.

I care deeply about the health of our wetlands, watersheds, and migratory bird habitats. Birds are declining across North America, and habitat loss is a major driver. A significant portion of this parcel is mapped as a Wetland Class Area, meaning development here would directly eliminate habitat in the short term and degrade the surrounding wetland system over time through noise, lighting, runoff, and other disturbances.

Heavy commercial uses, including truck repair, can be located in many places. But a wetland that supports migratory birds and contributes to the Yahara exists only where it is, and only for as long as we do not damage it. Preserving areas like this is essential for protecting water quality and the health of the ecosystems downstream.

For these reasons, I respectfully ask the Committee to deny the rezoning petition and keep this environmentally sensitive area protected.

Dear Dane County ZLR Committee,

I am writing to express my opposition to rezoning parcel File #12275 from F35 Farmland Preservation to Heavy Commercial for the proposed diesel truck repair business near the Vienna Ponds wetland complex at the intersection of Patton Road and Highway V.

While I do not oppose the truck repair business itself, I strongly oppose this proposed location. The Vienna Ponds area is an ecologically sensitive wetland complex and an important migratory and wildlife corridor at the headwaters of the Yahara watershed. This area provides critical habitat for numerous bird species, including wetland-dependent and migratory birds, and is recognized as a significant birding hotspot in Dane County, with over 215 species recorded.

The proposed development appears incompatible with the surrounding landscape, which includes adjacent publicly protected lands such as the Vienna Waterfowl Production Area managed by the U.S. Fish and Wildlife Service and the Vienna Pothole Wildlife Area owned by Dane County. Rezoning this parcel to Heavy Commercial risks introducing increased traffic, noise, pollution, and habitat fragmentation immediately adjacent to these valuable conservation lands.

Maintaining this parcel as farmland preservation or pursuing long-term conservation-oriented land use would better support wildlife habitat, water quality, and stewardship goals for Dane County. Allowing industrial development in this location would undermine the ecological integrity of an area that is already recognized for its scientific, scenic, and wildlife value.

I respectfully urge the committee to deny the rezoning request for File #12275 and protect this environmentally sensitive area from incompatible development.

Dear Mr. Bollig & Dane County Planning,

I am writing to respectfully request that you **deny the proposed zoning change petition (File #12275)** for the property located at the **southwest corner of Patton Road and Highway V, Section 21, Town of Vienna**.

This property lies directly adjacent to — and includes portions of — the **Vienna Pothole Wildlife Area**, a critically important wetland and migratory bird oasis that must be protected. This wetland supports a remarkable diversity of wildlife, including **rare and declining bird species** that rely on it for resting, nesting, and breeding habitat.

Species such as **Yellow-headed Blackbirds** and **Common Gallinules** (both uncommon breeders in Dane County) depend on this site during the summer months. In addition, a **Eurasian Wigeon**, a species rare not only to Wisconsin but to the United States, was documented here recently during migration. Hundreds of bird species use this wetland complex as part of essential migratory flyways. Given that North American bird populations have declined dramatically since the 1970s, protecting intact wetlands like the Vienna Potholes is more critical than ever.

The proposed rezoning area includes a **substantial portion of this wetland complex**, and the surrounding farmland has flooded repeatedly in recent years. Allowing a **diesel truck repair facility** in such a flood-prone area poses a serious environmental risk. Petroleum products, solvents, and other industrial chemicals would inevitably enter surface water during rain events, leading to contamination of the wetlands and ground water. Wetlands function as natural filtration systems, and introducing industrial pollutants into this ecosystem would cause irreversible harm. This proposal is short-sighted and environmentally irresponsible.

Instead, I urge the County to **consider purchasing this land** to expand the existing wildlife protection area. This site is already heavily utilized by community members for **birdwatching, wildlife photography, walking, and outdoor enjoyment** throughout the year. Expanding permanent protection would benefit not only wildlife, but the many residents across Dane County and the State who value this unique natural area.

Improved non-motorized access—such as a small, safe access point away from Highway V—and improved pathways could enhance public enjoyment while protecting the resource. Preserving the remaining land as a non-agricultural, protected area would greatly increase public benefit without compromising ecological integrity.

Allowing a noisy, polluting mechanical facility next to a sensitive wetland undermines the very purpose of this protected area. These wetlands exist for the benefit of the broader community and future generations—not to be degraded for the short-term gain of a few.

For these reasons, I respectfully ask that you **vote against the proposed zoning change** and instead pursue permanent protection of this land.

I am writing to submit my formal public comment in strong opposition to Petition 12275, which proposes the development of the Hwy V Wetlands (Vienna Ponds) in Dane County for the construction of a diesel repair facility.

Siting a diesel repair facility on or adjacent to the Hwy V Wetlands poses an unacceptable risk of contamination to this sensitive area. Diesel fuel, motor oil, hydraulic fluid, and other chemicals associated with heavy equipment repair are highly toxic to aquatic and wetland ecosystems. Dear Members of the Committee,

As stewards of the Yahara River Watershed, we respectfully request that the petition to rezone parcel #0909-211-8000-3 at the southwest corner of Patton Road and Highway V in the Town of Vienna for the development of a heavy-duty diesel repair facility be denied. This proposal threatens an ecologically significant wetland corridor that provides critical wildlife habitat, flood mitigation, water filtration, and recreational value for the broader Yahara watershed and surrounding communities.

The wetlands in this area support a remarkable diversity of wildlife that is greatly appreciated by bird enthusiasts. There is publicly available birding data that document hundreds of bird species observed within this corridor, including rare and sensitive species such as the black-crowned night heron, black tern, Virginia rail, Henslow's sparrow, American white pelican, and the federally protected bald eagle. These marshlands also provide essential habitat for vulnerable and endangered species, including Blanding's turtles, little brown bats, rusty-patched bumblebees, native orchids, amphibians, and spawning game fish that depend on healthy wetland ecosystems.

This parcel is directly adjacent to and connected to the waters of the Vienna Waterfowl Production Area owned and managed by the U. S. Fish and Wildlife Service. This important area is part of the Vienna Pothole Wildlife Area, which takes its name from the many shallow depressions, or potholes, left behind by retreating glaciers. This distinctive topography is known as the "Duck Factory" of North America, with prairie potholes producing nearly half of the continent's ducks.

The wetland found on this parcel is connected to the broader Yahara River watershed and lies upstream from Cherokee Marsh, Dane County's largest remaining wetland. Recognizing the ecological importance, Dane County, the City of Madison, the Village of DeForest, and the Wisconsin Department of Natural Resources have worked hard to protect nearby wetlands and uplands. Allowing further industrial encroachment into this sensitive corridor would undermine and diminish decades of public conservation investment and stewardship.

Beyond their ecological significance, wetlands provide substantial benefits to surrounding communities. They absorb heavy rainfall and reduce flooding impacts for the Town of

Vienna, the Village of DeForest, and downstream communities. They naturally filter sediment, nutrients, and pollutants from stormwater runoff before those contaminants reach the Yahara River and Lake Mendota. Wetlands also recharge and discharge clean groundwater that helps maintain water quality throughout the watershed. In addition, area wetlands offer valuable opportunities for fishing, paddling, walking, wildlife observation, and environmental education.

The Village of DeForest's 2025 Comprehensive Plan emphasizes the importance of protecting environmental corridors, improving water quality in the Yahara watershed, and preserving open green space. Approval of this rezoning request would disrupt those goals and hamper broader regional efforts to improve watershed health.

There is already sufficient land designated for business and industrial development within the region that can accommodate economic growth without sacrificing irreplaceable wetlands and environmentally sensitive areas. Development should be directed toward appropriately zoned locations where infrastructure and land-use planning already support industrial activity, rather than consuming critical natural habitat.

Your decision on this matter will have lasting consequences not only for this wetland, but for the continued health of the entire Yahara watershed and Dane County's chain of lakes — Mendota, Monona, Wingra, Waubesa, and Kegonsa.

We respectfully ask that you prioritize long-term environmental stewardship, watershed protection, and responsible land-use planning by rejecting this rezoning petition.

Take the short drive to the intersection of County Hwy V and Patton Rd, then turn and look to the west/southwest. What you will see are wetlands. The Yahara Watershed. The parcel of land (40acres) that abuts the above mentioned 38 acre, is owned by the United States Fish and Wildlife Service. The 82 acre parcel of land to the west and southwest of that USFWS 40 acre was recently purchased by Dane County in 2019. David Lynch, the owner of the 50 acre parcel to the south of proposed rezoning, has made it his business to conserve and protect these wetlands for the past several years.

These lands were important enough for both the USFWS as well as Dane County to obtain. On October 15, 2019, County of Dane posted an article on the County's website, "Dane County to Purchase 82 Acres of Property for Floodwater Storage in the Yahara Watershed". Read it out loud in the meeting. It would be hypocritical for the county to approve of such zoning that would endanger the very watershed they are trying to protect. Diesel, hard metals, and other petroleum based lubricants WILL find their way into The Yahara Watershed, not only contaminating water, but destroying the ecosystem surrounding it.

I'm writing regarding the proposed rezone of a truck repair business on the Vienna Ponds. The Dane Cty ZLR Committee is currently reviewing the proposal and will tentatively act on a petition to rezone it to Heavy Commercial for development of a diesel repair business on May 26.

This parcel of land has valuable wildlife value, to wit: The County V Ponds rank #14 in Dane County with 215 species entered in eBird and #14 with 3,186 complete checklists. In the past two months 96 species have been recorded! The 96 species includes wetland birds that probably nest in the wetland complex, uncommon or birds of special interest - Greater White-fronted Goose, Blue-winged Teal, Mallard, Eurasian Wigeon, Ruddy Duck, Pied-billed Grebe, Horned Grebe, Virginia Rail, Sora, Common Gallinule, American Coot, Wilson's Snipe, Spotted Sandpiper, Lesser Yellowlegs, Greater Yellowlegs, Bonaparte's Gull, Double crested Cormorant, American White Pelican, American Bittern, Least Bittern, Great Blue Heron, Great Egret, Cattle Egret, Bald Eagle, Merlin, Marsh Wren, Yellow-headed Blackbird.

Currently the Fish and Wildlife Service owns the 39 acre Vienna Waterfowl Production Area adjacent to the proposed truck repair business. Dane County owns the 81 acres Vienna Pothole Wildlife Area. The adjacent landowners that own wetland habitat are VERY supportive of protecting the wetland.

Please don't rezone this property for commercial development, thus preserving valuable upland grass habitat for wildlife and improving water quality. This environmentally sensitive area and critical wildlife corridor need not be developed, and the truck repair business can certainly avail themselves of a viable alternative parcel nearby to this sensitive natural area. As a resident of the Town since 1965 and a bordering landowner I oppose this rezone request. Zoning this parcel for heavy commercial use will create significant adverse impacts to all adjoining properties established land use of recreation and providing habitat for wildlife. A geographically unique glacial rift and pot hole features of scientific interest, this wetland complex has historically served as a major source of water filtration and retention contributing to the healthy functioning of the Yahara Watershed.

Damages to my land will be most severe. As an active member of DMAP, a wildlife habitat improvement program managed by DNR, I have substantial time, labor and finances invested in this bordering property. Last year the DNR initiated a statewide pilot program of DMAP to determine the feasibility of investing in acreages less than 160 acres. One property was selected to represent each County, my property represents Dane County.

PIC1 In keeping with the Town Plan of "maintaining wetlands as buffers between uses and as natural habitat for wildlife" as well as "the preservation of open space to maintain the rural character of the Town" my land management efforts are in sync with these objectives and adjoining land use.

PICS 2&3 Contrary to statements made that the parcel is a part of the HC industries currently in the area, it is not. Clearly shown is a natural corridor of wetland and heavily wooded hillside allowing for the annual migration of turtles, frogs, salamanders and free roaming wildlife while buffering the activity, noise, vibrations, lighting and presence of pollutants associated with such industries. With the exception of an occasional flat bed of steel entering E80, HC trucking is prohibited by Town order to use this section of Patton Rd that traverses the wetlands. HC trucking must use County I to enter and exit the district.

Functioning as a wetland, this basin is also sensitive to changes in the surrounding landscape. In the past five years mining and intensified agricultural practices are increasing the volume and rate of storm water entering the wetlands. Clear cutting hill tops for mining and tiling the slopes and bottoms of the croplands below for discharge affects fluctuating high water and seasonal saturation levels. Developing on this parcel will only add to the loss of retention and natural flow of stormwater runoff and potentially threaten the integrity of retention ponds utilized as pollutant treatment systems.

As a full service diesel repair shop Madison Springs has taken extraordinary engineering measures to site on this parcel. Given the fact these measures are required demonstrates the high risks involved without them. Madison Springs asks you to agree there will be No risks to our waters, factoring in human error, climatic events, transfer, usage, disposal, treatment and containment of all pollutants that could be hazardous to this environmentally sensitive complex. That is extraordinary. Employing such measures may MINIMIZE the loss of pollutants shed by equipment parked on site and other unintended factors to a little bit, at

what point does a little bit become a lot?

By shoehorning Heavy Commercial into this environment is not only fragmenting our critical resources but is intentionally introducing pollutants and risks that have historically been absent. Once the natural state of the complex is disturbed it will have a permanent negative impact on this wetland as a whole.

My name is Carol Lynch and I am an adjoining property owner to the property being considered for zoning change to HD commercial. I want to start by saying I think we can all agree that having Madison Springs come to Vienna would be a benefit to the town in regards to economic development and increased tax base. I think we can all further agree that the dry knoll in parcel 064 0909211 8003 is surrounded by wetlands and hydric soils and thus constitutes an environmentally sensitive area which is prone to flooding. This parcel is included in a 180-acre wetland complex and is a major wildlife corridor.

Diesel repair shops handle a range of chemicals that can pose health, fire, and environmental hazards. These include:

Engine and lubrication fluids

Diesel fuel and diesel exhaust fluid (DEF)– Highly flammable; DEF is a urea-based solution that can cause skin and eye irritation if mishandled

Used engine oil and lubricants– Often contain heavy metals and hydrocarbons; classified as hazardous waste if not properly managed.

Transmission and gear oils–Contain additives that are toxic if ingested or inhaled.

Cleaning and degreasing agents

Brake cleaner– Contains acetone or other volatile solvents; flammable and can cause respiratory irritation

Solvents and degreasers– Used to clean parts; many are volatile organic compounds (VOCs) that can cause eye, skin, and respiratory irritation

Welding and metal cleaning solvents– May contain chlorinated or aromatic compounds.

Paints, coatings, and adhesives

Spray paints and primers– VOCs and flammable vapors; require proper ventilation and PPE

Paint strippers– Often contain strong acids or alkalis that can cause chemical burns

Coolants and antifreeze

Ethylene glycol-based coolants– Toxic if ingested; can cause kidney damage

Propylene glycol-based coolants– Less toxic than ethylene glycol but still hazardous.

Battery fluids

Sulfuric acid– Highly corrosive; can cause severe burns and respiratory damage

Other specialty chemicals

Diesel particulate filter (DPF) cleaning solutions– May contain strong acids or oxidizers.

Air conditioning refrigerants– Some are ozone-depleting or toxic if leaked.

The vehicles entering and leaving the repair shop area all have these substances on them as well as road salts.

I think we can all agree that any of these ingredients being introduced into the wetlands is not a good idea for the health of the wildlife and the humans that rely on this wetland to clean and recharge our groundwater.

Madison Springs has taken extraordinary measures regarding their storm water management plan which should tell you how serious of a threat this business poses to the wetland. Moreover, these extraordinary measures will **reduce** the amount of substances introduced into the wetland, however, they **cannot prevent all** of them from entering the soil and groundwater. I ask the committee to strongly consider the

consequences of allowing these toxins to enter this wetland.

This wetland is already being subjected to agricultural pollutants due to tiling and pumping of storm water from CAFOs in close proximity and the loss of woodlots due to the gravel pit operations. It is not a good justification to further subject the wetlands to more pollution just because these risks already exist.

Rather than squeezing this development onto this dry knoll, we should be looking for a safer alternative location for this development. A heavy commercial business does not fit in with the surrounding properties current uses.

Dane County Land and Water Resources Department is actively working to protect, restore and recapture wetlands that have been degraded or destroyed. How would rezoning this parcel fit this objective? Wouldn't it be better to preserve this wetland rather than potentially having to restore it at a later date?

For these reasons I strongly oppose the rezoning of parcel 064 0909211 8003. I am asking Dane County to protect this environmentally sensitive area that the Town of Vienna states they will do in the comprehensive plan, however, by developing this parcel as heavy duty commercial, they are not protecting it.

We are against the rezone of the 38 acres to allow a truck repair business to be placed adjacent to the Vienna Waterfowl Production Area (WPA) and the Vienna Ponds. We are not against the truck repair business but are against the proposed location. The Fish and Wildlife Service chose to establish a WPA at the location because it was a super location to benefit wetland associated wildlife, help maintain water quality, and to provide a place for visitors. There are about 40 WPA's in 17 southeastern counties. Funds from sales of "duck stamps" by waterfowl hunters and bird watchers are used to purchase the properties.

We have been the managers at Goose Pond Sanctuary, 6.5 miles to the north of the Vienna Ponds since 1979. Goose Pond Sanctuary is owned by Southern Wisconsin Bird Alliance (SoWBA), formerly Madison Audubon Society. We are both retired from the DNR and were conservation biologists. Mark worked 40 years on wildlife research and with the State Natural Areas program on land protection and management. Sue is a retired conservation biologist with the DNR. We have observed the Vienna Ponds for over 45 years. Up to about 1993 the wetlands did not hold much water. However, we observed that since about 1993 the water levels have increased and the area covered by water has also increased.

Vienna Ponds, a wetland complex and migratory hotspot, is at the headwaters of the Yahara watershed and is of scientific, scenic and wildlife interest. The 38 acres should be protected and the uplands restored to grassland (prairie) cover to provide upland grass habitat for wildlife nesting and improving water quality. The adjacent landowners that own 60 acres including wetland habitat south of the parcel up for rezoning are supportive of protecting the wetland to preserve the quality of this important stopover site for migratory birds and critical breeding

ground for species of special conservation concern.

The County V Ponds are a popular destination for birds and bird watchers. This area provides ideal wetland habitat and is of special recreational, scenic, and scientific interest. eBird records help document species abundance and locations. The area was not within a random priority block on the Wisconsin Breeding Bird Atlas II. However, at least 19 wetland associated species were confirmed or probably nested at the Vienna Ponds. We recently learned that the federally endangered Whooping Crane has also been seen at the site.

At Goose Pond Sanctuary in Columbia County, SoWBA has purchased land to help reduce the amount and increase the quality of water flowing into the Yahara River. We hope that ZRL committee does not approve the rezone request.

All these agencies along with the Federal Government are supposed to manage these resources for their health and ecological value.

It is not like there is no property in the area already zoned for commercial use. The Town plan use to be exclusive ag and protect farmland in the township, which is rapidly disappearing.

I ask the committee to think about protecting the recreational value of this parcel and vote no for the rezone. If you vote to allow this petition I would recommend at a minimum that this change be handled as a conditional use permit, rather than the zoning change. This would give the town and Dane County some enforcement annually if the user does not live up to agreed conditions, such as Landscaping, Lighting, drainage, vehicle parking, fencing etc. This would be similar to managing the Payne and Dolan Asphalt plant on Easy street.

In closing please consider how your decision will not only change this parcel now, but other future uses as well.

I'm writing to oppose the proposed zoning change of parcel 0909-211-8000-3 from a FP-35 Farmland Preservation District to a Heavy Commercial district. This land abuts and shares a large pond with the Vienna Pothole Wildlife Area. This pond is excellent breeding and migration stopover habitat for many bird species. Over 200 bird species have been identified there, including a recent multi-day stopover of an endangered Whooping Crane (photo attached). Sensitive species such as Whooping Cranes can be discouraged from using suitable habitat by the regular presence of humans close to the habitat, increased noise, and nighttime outdoor lighting. While there are some nearby (across the street) HC zones and commercial buildings, placing a semi truck repair business immediately adjacent to the wetland and wildlife area would substantially decrease the value of the wildlife area both as habitat for the birds and as wild land for the humans who recreate there.

I am writing to express strong opposition to rezoning parcel 12275 from Farmland Preservation to Heavy Commercial for the proposed diesel truck repair business adjacent to the Vienna Ponds wetland complex.

This is not an objection to the business itself, but to the proposed location. The Vienna Ponds area represents one of the most important wetland and migratory bird habitats in southern Wisconsin. Located at the headwaters of the Yahara watershed, this landscape provides critical ecological functions that are increasingly rare and increasingly vulnerable across the region.

Wetlands are among the most imperiled habitat types in North America. They have already experienced extensive historical loss through drainage, fragmentation, and development. What remains carries disproportionate importance for wildlife, water quality, flood mitigation, and biodiversity. Once ecological integrity in these systems is compromised, recovery is often slow, incomplete, or impossible.

The County V Ponds eBird hotspot ranks among the most active birding locations in Dane County, with more than 215 documented bird species and thousands of submitted checklists. In just the past two months alone, observers recorded 96 species, including marsh birds and wetland-dependent species such as American Bittern, Least Bittern, Virginia Rail, Sora, Yellow-headed Blackbird, Marsh Wren, Wilson's Snipe, and numerous migratory waterfowl and shorebirds.

Most notably, this spring a Whooping Crane, one of North America's rarest and most iconic endangered bird species, used the County V wetland complex as a migratory stopover site for several days before continuing north to its breeding grounds. The presence of a Whooping Crane is not only ecologically significant, but also a powerful reminder of how important intact wetlands in southern Wisconsin remain for vulnerable migratory species. Places like Vienna Ponds are not interchangeable landscapes. They are functioning habitat networks that endangered wildlife depend upon during migration.

What concerns many of us is the type of loss that often goes unnoticed until it is too late. Wetlands are rarely destroyed all at once. More often, they are incrementally degraded through incompatible adjacent land uses, increased noise, lighting, runoff, traffic, pollution, habitat fragmentation, and disturbance pressure. The result is a gradual unraveling of ecological function. Birds stop nesting successfully. Sensitive species disappear quietly. Migration use declines. Water quality worsens. These changes are easy to miss year to year, but collectively they represent a profound and lasting loss.

This proposal is especially troubling because the site directly borders protected and publicly

valued habitat, including the Vienna Waterfowl Production Area owned by the U.S. Fish and Wildlife Service and the Dane County Vienna Pothole Wildlife Area. These conserved lands exist precisely because this landscape is environmentally sensitive and ecologically important.

Good stewardship requires recognizing when a proposed land use is fundamentally incompatible with the surrounding environment. There are other locations better suited for heavy commercial development. There are far fewer remaining high-functioning wetlands and migratory stopover habitats.

I respectfully urge the committee to deny petition 12275 and protect this critical wetland complex and wildlife corridor for future generations.

Southern Wisconsin Bird Alliance (SoWBA) respectfully submits these comments expressing our serious concerns about petition 12275, which proposes to rezone 38.6 acres at the southwest corner of Patton Road and County Highway V in the Town of Vienna from FP-35 (Farmland Preservation) to HC (Heavy Commercial) to accommodate a truck repair and maintenance facility for Madison Spring. SoWBA is a regional leader in land conservation, habitat restoration, and environmental advocacy, representing members throughout Dane County and southern Wisconsin. Our 736-acre Goose Pond Sanctuary includes a diversity of native habitats, including important wetland types, and is located approximately 6.5 miles north of the proposed project.

We wish to be clear at the outset that we do not oppose Madison Spring as a business. The company has an established reputation for quality service dating back to 1967, and the application materials suggest a genuine commitment to regulatory compliance and responsible operations. Our concern is with the proposed location, which we believe poses unacceptable risks to an ecologically irreplaceable wetland complex.

A Regionally Significant Wetland Complex

The subject parcel is immediately adjacent to the County V Ponds, a wetland complex of exceptional ecological significance. It is a popular spot for birders and according to eBird.org, this area has been designated a birding hotspot (#14 in Dane County and #57 in Wisconsin) with 215 bird species recorded from 3,186 checklists, figures that reflect the exceptional quality and diversity of habitat this wetland supports. The site provides critical habitat for migratory waterfowl, shorebirds, wading birds, and many other species that depend on high-quality wetland systems. Among the many bird species recorded are the American Black Duck (WI species of special concern), Great Egret (state-threatened), and Black Tern (state-endangered).

The wetland complex is both privately and publicly owned, with lands held by both the U.S. Fish & Wildlife Service (39 acres of the Vienna Waterfowl Production Area) and Dane County (81 acres of the Vienna Pothole Wildlife Area). Development immediately adjacent to publicly protected wildlife lands warrants an especially high standard of scrutiny.

Concerns Raised by Dane County Land and Water Resources

Comments submitted by the Dane County Land and Water Resources Department (LWRD) raise serious environmental concerns that we believe the Committee must carefully consider.

- The Vienna Pothole wetland complex now serves as the primary outlet for what was formerly one of the largest internally drained watersheds in Dane County. As a result of upstream flood mitigation work, water now moves through this system more rapidly, reducing residence time and diminishing its historic capacity to treat pollutants before they move downstream.

- Point source monitoring has already detected elevated pollutant levels entering this wetland. A commercial truck repair operation on an immediately adjacent parcel would introduce additional pollutant risks with limited upland buffer to intercept them.
- The wetland drains to Wheeler Wilcox Creek, a coldwater tributary of the Upper Yahara River, which has recently been classified by the Wisconsin DNR as trout water. This classification reflects improving water quality and active investment by the Village of DeForest and other partners in fish habitat restoration along this stretch of the river. A significant pollution event on or near the proposed site could jeopardize these conservation gains.
- Aerial photographs from June 2009 show the subject parcel partially inundated during high water events, underscoring the hydrological connectivity between the development site and the surrounding wetland system, and raising concerns about the adequacy of even the most stringent containment measures during flood conditions.

Incompatibility with the Surrounding Landscape

The zoning map included with the application illustrates that the proposed HC rezoning would represent a significant departure from the surrounding land use pattern. The area is predominantly characterized by FP-35 Farmland Preservation, NR-C (Natural Resource Conservation), and low-density residential zoning classifications. While there are existing HC parcels in the vicinity, rezoning this particular parcel that sits in close hydrological contact with a protected wetland complex is qualitatively different. The application's inspector also noted that wall lighting appears too intense for a rural area and that light color temperature needs to be reduced due to the neighboring wildlife area, both of which highlight compatibility challenges with the surrounding natural environment.

Conclusion

The County V Ponds wetland complex is a remarkable ecological resource that provides flood protection, water quality treatment, wildlife habitat, and public recreational. It is recognized as a regionally significant birding destination and forms part of a connected system of publicly protected lands managed for conservation in perpetuity. Furthermore, Dane County's Code of Ordinances 11.10(2) prohibits rezoning of a wetland, or a portion thereof, if the proposed rezoning may result in significant adverse impact upon numerous factors, including fish spawning and wildlife habitat. The majority of the parcel is clearly classified as wetland by the Wisconsin Wetland Inventory and the proposed project is indeed likely to cause adverse impacts.

Madison Spring deserves a site that allows the business to operate and grow without the environmental constraints and risks inherent to this location. We urge the Committee to deny this petition and encourage the applicant to identify an alternative site that does not place heavy commercial truck repair operations in immediate proximity to an irreplaceable wetland complex.
