D. Presentations

1. Tour of ADRC and Presentation of Services

Jennifer Fischer, ADRC manager, provided a presentation describing ADRC services and providing a tour of the facility. The ADRC accepts walk-in clients and prescheduled appointments. The Program Specialists connect disabled and elderly individuals to eligible community resources. The two most common topics discussed are public benefits and housing. Fischer describes the ADRC as the Best Prevention Program for disabled and elderly individuals. The Commission suggested sending ADRC information to all the Dane County Supervisors to expand awareness of the center.

1. Staff Reports

1. Car Loan Program

The car loan program in Dane County is contracted with SWCAP. An article regarding the success of the revolving car loan and car repair program will soon be published in a trade magazine for community banks.

2. RFP

RFP evaluation results will be completed by April 30, 2015. The projected transportation start up date for the awarded providers is June 1, 2015.

3. NCST

As previously noted the component of the National Center for Senior Transportation (NCST) grant, seniors being discharged from the hospital will be counseled regarding transportation needs to their first follow up post hospital doctor visit, has been discontinued. Dane County may consider selecting a different hospital to partner with on this project in the future. The Commission discussed possibly including a hospital representative as a member of the STC. The component of the NCST grant in partnership with RSVP, bus-familiarization excursions for seniors which include training on how to use the public bus continues to move forward. The ADRC will refer clients to the RSVP bus-familiarization and mobility training programs if they are identified as individuals who are ready to give up driving.
