<b>Intent/Justification</b>			
<p>A new half-time social worker for the PRP is the most cost effective way to gather information to best inform the juvenile court process. Parents are reluctant to divulge all information to government social workers, particularly when the worker has removed children from the home. This, in turn, will lead to better and faster identification of possible informal supports for the family, which is likely to lead to faster safe &amp; effective permanency through reunification, relative placements or guardianships by those the parents trust. That would end court jurisdiction and the need for costly out of home care and formal service provisions. This position will assist attorneys by doing some of the investigatory work the attorneys now do for themselves.</p> <p>This is the top request of the 17 judges.</p>

<p>Recent events have shown that local government meetings and offices can be a target for gun violence. In 2015 in San Bernadino County and in 2019 in Virginia Beach, gunmen targeted local government meetings or offices. Dane County was itself targeted in 1988, when two county employees were killed by a gunman in the City-County Building. While no amount of security can guarantee safety, this amendment will increase the level of protection by providing a Dane County sheriff's deputy to attend meetings of the county board. In addition to the primary function of providing security, the deputy will provide assistance to the public attending the meetings (e.g. giving directions and answering general questions), much as the bailiffs currently do at the Dane County Courthouse.</p>
