D. Presentations

1. Dane County Budget Presentation - Joe Parisi, Dane County Executive, & Lynn Green, Dane County Human Services Director

Green thanked Chair Murray and the Commission for their work. The 2019 DCDHS budget is \$13 million less than 2018 due to completion of Family Care transition and removing all waiver revenue from the budget. Some grants were lost but we were able to backfill to keep programs. There were no staff layoffs, no cuts in purchased services and some minor expansions. She highlighted programs that pertain to sensitive crimes. Dane County Executive Parisi and the County Board added over \$6 million to DCDHS.

County Executive Parisi expressed appreciation to members for their work. He highlighted the following: Journey Mental Health mobile mental health crisis unit expanded, two new CPS positions to work with families that workers are concerned about but don't meet the definition to screen in, CRC expanded, county workers received a 3.5% pay increase, POS received a 3.5% administrative increase, a new program leader position at NIP to focus on sex trafficking, added a trauma social worker position at NIP, housing advocate to work with youth, JFF eviction prevention fund increased by \$50,000, increased Planned Parenthood funds for education, added another JFF worker, and another senior case manager. The County Board added \$20k to the Rape Crisis Center for prevention education, added two additional program leader positions at NIP to address community violence, \$20k to Outreach for a transgender advocate, and increased Rainbow House funding by \$70k.

There was discussion about:

- The trauma response team for county staff and whether it could be expanded to POS.*
- Addressing trauma for children with intellectual abilities as they are highly targeted for sexual assault.*
- Developing affordable housing in Dane County and the need for support services to go with it.*
- Need for crisis housing.*
- Challenges with increase in juvenile crime.*

E. Reports to Committee

1. Legislative Update/Announcements:

- McCarville was elected Chair of PP&J. She provided an update on the jail process.
- Murray commented on Marcy's law, a proposed legislative amendment affecting victim rights.
- Kato reported that Rainbow opened a new branch effective January 1 . Two early childhood zones opened in Sun Prairie on November 1.
- Veerhusen provided Meriter Forensic Nursing sensitive crimes statistics for 2018 (see attached) and requested feedback on how to serve different populations better.
- Barry reported that DAIS waitlist numbers are high for shelter services, so the team is reviewing the intake process and needs feedback from community partners.

- Child Abuse & Neglect: Kato distributed the attached mapping flow chart. The November Trauma Informed Community Summit was a huge success and planning has begun for next year.
- Intellectual Disabilities: Pomije noted that the I/DD CCR did not meet in December, so there is no update for COSC.
- Domestic Violence: No report.
- Elder Abuse: Scarr provided the following written report. EACCR- January meeting featured SSM Health at Home presentation about all of their services and keeping elder safe in their homes and communities; February meeting will feature WI Legal Action's Elder Rights Project presentation. WEAAD- World Elder Abuse Awareness Day- June 15th; events planning underway. FAST- Financial Abuse Specialist Team- January 24th mtg at Madison's Ho-Chunk Community Center for tours and presentation on their elder services. HTF- Hoarding Task Force- New committee chair and members; focus on resource sharing and Law enforcement's response in the community. DVinLL- Domestic Violence in Later Life- 2019 conference planning underway; focus on various technology as tools of violence and abuse and how elders can combat and recover.
