3. Salmo Pond construction update

The parking lot and vault restroom construction project is complete. Park operation staff removed the old vault toilet and installed the new vault, which is precise work. Dane County Parks is very lucky to have such a talented and knowledgeable crew. Staff and volunteers planted over 1,700 native plant plugs in the new stormwater basins. The project also included pathway improvements to the fishing piers and added a new picnic table as part of the Dan Wisniewski Accessible Fishing Area. A memorial boulder will be placed on site later this summer and a small dedication ceremony may be planned with the family at a later date.
