1. Friends of McCarthy Youth & Conservation County Park

The Friends of McCarthy Park volunteer in a number of different ways in the park. They groom the cross-country ski and snowshoe trails, planted and maintain the pollinator garden, develop the Ho-Chunk interpretive trail, host Ho-Chunk youth educational programs, hold a youth service day annually and assist with land restoration.

2. History and Overview of McCarthy Youth & Conservation County Park

The vision for McCarthy Youth and Conservation Park began in 1974 with a donation of 180 acres of land that was owned by Russell and Ella McCarthy. They retained a life estate and the property started converting to a park in the early 2000's. The McCarthys' goal was for the park to become "a place where kids from the city could learn about nature." The park offers a group camp, hiking, cross-country skiing, equestrian trails and camping, picnic opportunities, and a beautiful prairie/wetland restoration.
