**RESOLUTION EXTENDING INTERAGENCY AGREEMENT BETWEEN THE DANE COUNTY
DISTRICT ATTORNEY'S OFFICE AND COTG2021 FOR CONTINUED COMPREHENSIVE
DRUG TESTING FOR THE DEFERRED PROSECUTION PROGRAM**

A previously negotiated Interagency Agreement Amendment with the Dane County District Attorney's Office and the COTG2021 to provide comprehensive drug testing for the Deferred Prosecution Program expired on December 31, 2025.

An extension of the Interagency Agreement Amendment to comprehensive drug testing for the Deferred Prosecution Program Agreement has been negotiated as Follows:

Revision: increase the contract total from the current amount of \$99,000 to a total of \$ 139,000, a change of \$40,000.

Revision: Change the end date from March 20, 2026 to December 31, 2026.

All other terms and conditions of the original agreement remain unchanged.

This contract addendum exceeds \$100,000 and requires a resolution and confirmation by the Dane County Board of Supervisors.

NOW, THEREFORE, BE IT RESOLVED that the County Executive and the Dane County Board of Supervisors authorize the year four extension to this agreement.



DANE COUNTY CONTRACT

ADDENDUM # 15156C

THIS ADDENDUM, made and entered into effective as of the date by which both parties hereto have executed this document, by and between the County of Dane (hereinafter referred to as "County") and **COTG 2011** (hereinafter, "Provider").

WITNESSETH:



WHEREAS Provider and County, by a separate document (hereinafter, the "Master Agreement"), Dane County Contract # 15156 , have previously entered into a contractual relationship pursuant to which Provider provides comprehensive drug testing for the Deferred Prosecution Program, and

WHEREAS County and Provider wish to amend the Master Agreement in order to \$40,000 to the contract and extend the contract term.

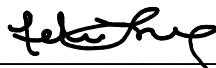
NOW, THEREFORE, in consideration of the above premises and the mutual covenants of the parties hereinafter set forth, the receipt and sufficiency of which is hereby acknowledged by each party for itself, the parties do agree as follows:

1. The Master Agreement shall remain in full force and effect unchanged in any manner by this addendum except as changes are expressly set forth herein. This addendum shall control only to the extent of any conflict between the terms of the Master Agreement and this addendum.
2. The Master Agreement, and any amendment or addendum to it, may be executed and transmitted to any other party by legible facsimile reproduction or by scanned legible electronic PDF copy, and utilized in all respects as, an original, wet-inked manually executed document. Further, the Master Agreement and any amendment or addendum thereto, may be stored and reproduced by each party electronically, photographically, by photocopy or other similar process, and each party may at its option destroy any original document so reproduced. All parties hereto stipulate that any such legible reproduction shall be admissible in evidence as the original itself in any judicial, arbitration or administrative proceeding whether or not the original is in existence and whether or not such reproduction was made by each party in the regular course of business. This term does not apply to the service of notices under the Master Agreement, or any subsequent amendment or addendum.
3. The term of the contract is extended through December 31, 2026 to continue the program for Comprehensive drug testing for the Deferred Prosecution Program at an additional cost of \$40,000. The total value of the contract and all addenda is now 139,000.
