Support for the newly-introduced Healthy Aging Grants legislation at the State. This legislation would provide Wisconsin Institute for Healthy Aging (WIHA) \$378,000 in annual funding for 2 years to support the Falls Free Wisconsin initiative as well as the delivery of evidence-based health promotion programs and practices and would enable WIHA to offer Localizing Efforts to Address Falls (LEAF) grants again.

Bills have been introduced in both the state Senate (SB 407 - referred to the Senate Health Committee) and state Assembly (AB 418 - referred to the Assembly Health, Aging & Long-Term Care Committee) with 17 co-sponsors.
