AUTHORIZING AN AGREEMENT TO ACCEPT HIGHWAY SAFETY GRANT FUNDS FOR A SPEED ENFORCEMENT TASK FORCE PROJECT

Policy Analysis Statement:

Brief Description of Proposal -

The WI Department of Transportation, Bureau of Transportation Safety, is making funds available for participation in a 2015 Speed Enforcement Task Force Project, Grant Number FG-2015-DANE CO-02865; grant project period is March 1, 2015 through September 30, 2015. The goal of this federally funded enforcement project is to reduce traffic crashes in Dane County by focusing on speeding violations, aggressive driving, and seatbelt violations. Participating agencies in this enforcement effort are the Sheriff's Office and Madison Police Department, who will adopt a zero tolerance for impaired driving, and unrestrained occupants during all motor vehicle stops. The Dane County Sheriff's Office will be the administrator

Current Policy or Practice -

Acceptance of grant funding requires approval of the County Board.

Impact of Adopting Proposal -

In Wisconsin during 2013, speed-related crashes were a contributing factor in 18% of all crashes, and 28.9% of all fatal crashes. Excessive speed is often associated with other high-risk behaviors including following too closely and failure to wear safety belts that increase the likelihood of a crash, significant injury, and fatalities. Implementation of this project will save lives and make the roads safer for vehicles and pedestrians.
