Agreement for the Reconstruction and Jurisdictional Transfer of CTH F in the Village of Blue Mounds

# **Policy Analysis Statement:**

#### Brief Description of Proposal -

The Dane County Dept of Public Works, Highway & Transportation and representatives of the Village of Blue Mounds have determined that CTH F, needs to be reconstructed. In exchange, the Village agreed to accept the jurisdictional transfer of CTH F within the Village limits.

# Current Policy or Practice -

The Dane County Highway Dept has drafted an agreement to cover the cost charing for the reconstruction project, and for the jurisdictional transfer. The maximum share for the County is \$750,000 and \$670,000 for the Village.

# Impact of Adopting Proposal -

After a fund transfers the expense account HWCONCAP-59172 budget will be \$1,320,000, and the revenue account HWCONCAP-80903 budget will be \$670,000.
