AMENDING THE 2025 BUDGET TO COMBINE TWO 0.5 FTE POSITIONS INTO 1 FTE POSITION IN THE SHERIFF'S OFFICE

# **Policy Analysis Statement:**

#### Brief Description of Proposal -

The Sheriff's Office has a vacant 0.5 FTE Program Manager (position #3032) and a vacant 0.5 FTE Classification and Hearing Specialist (position #2075). The Sheriff's Office would like to combine these two 0.5 FTE positions into a 1.0 FTE Classification and Hearing Specialist.

#### Current Policy or Practice -

Requests to combine positions of different classifications to increase the budgeted FTE of one of the positions requires County Board approval.

# Impact of Adopting Proposal -

Creation of a one (1) FTE Classification and Hearing Specialist position shall reduce overtime use and workload within the Classification and Hearing work group in the Sheriff's Office Security Division. Timely classifications and administrative hearings ensure proper housing and due process for jail residents.
