Report on Behavioral Health Objectives - Work Groups Report Out

Report on Behavioral Health Objectives - Work Groups Report Out
Work Group 1: Chapter 51, 54, & 55 Statutes Judge Peacock describes the work group process. She has established small work groups to work on each objective with the assistance of the Office of Justice Reform, specifically, Shar-Ron Buie. Work Group reviews the processes especially in regards to Chapter 51. Review and research around better practices statewide and nationally.

Work Group 3: Medication Continuity During and After Release from Incarceration in the Dane County Jail.
Report by Judge Ann Peacock. Judge Peacock describes outreach to subject matter experts in the field including Well Path and the State of Wisconsin Department of Human Services. Work is ongoing in small work groups. Learning collectively with colleagues from other counties within the state that have developed incremental changes.
