 - 1 Zoo Director Report

Ronda Schwetz reported Zoo updates: Zoo budget update, capital project progress and projections for fiscal year 2014, and animal updates. Brief discussion of zoo updates and procedures to reduce costs and usage of utilities ensued including new primate building HVAC, Marathon engine in Aviary, solar panels in Herpetarium and Red Barn as well as geo-thermal well in Red Barn. Review of Capital improvements included Arctic Passage construction updates, zoo wide painting and pathway upgrade planned improvement. Brief discussion of potential conservation collaboration partners ensued.

2 Zoo Society Report

Alison Prange, Executive Director of the Friends of the Henry Vilas Zoo, reported on Zoo Society updates: There are several events planned at the zoo including membership appreciation night May 15 which will have food trucks, tours and free carousel and train rides, Dream Night at the Zoo on June 6 for critically ill children and their families, yoga at the zoo, Strings and Wild Things, the Chamber Orchestra will perform the night of July 8, the Dinosaur Exhibit opening May 16 in collaboration with the UW Zoology Museum and Family Day on July 16. Concessions and Gift Shop revenue is up from this time last year and the 2013 final budget will be reported at the next meeting. Additionally both Zoo and Society staff are working together on many grants to benefit Arctic Passage as well as other areas in the zoo.
