Dane County Department of Human Services Senior Program Analyst Lori Bastean delivered a PowerPoint presentation detailing the survey results and solicited suggestions prior to making the results public. Kusuda suggested a minor edit in the two-page synopsis.

Downing, a member of AAA's Nutrition/Wellness Committee, stated that members were pleased with the 90-plus percent favorable rating from respondents.

North/Eastside Senior Coalition Executive Director Jim Krueger inquired how many Spanish-language survey forms were returned and stated that many Spanish-speaking seniors who utilize NESCO's services cannot read and required help from case managers to complete the forms. Bastean will provide the number returned. Bastean stated efforts to improve the survey-taking process for Latino and Hmong clients should be a priority.

Wisconsin Bureau of Aging and Disability Resources (BADR) Office on Aging Supervisor Neal Minogue reported AAA's 2016-18 Area Plan was reviewed by six BADR staff members and approved. He will meet with AAA staff to seek clarification in some areas. Minogue saluted Dane County AAA for being a statewide leader in Nutrition and Health Promotion, and thanked the Board for its efforts regarding the Area Plan.

Clausius reported he has not received a response from the County Executive's office regarding the Board's concern that demographic parameters used to determine Board member eligibility are eliminating qualified candidates, leaving positions open for extended periods. Clausius met with Jeff Kostelic, Executive Assistant for Dane County Executive Joe Parisi, on 28 January 2016.

3. BOARD MEMBERSHIP

Batterman reported Board terms for Josephson, Kusuda, and McKinney will end in April. Josephson and Kusuda are eligible for reappointment. Kusuda volunteered to serve another term. McKinney will leave the Board after reaching the two-term limit.
