ACCEPTING STATE OF WISCONSIN "TRAUMA PROJECT" GRANT MONIES; CREATING REVENUE AND EXPENSE LINES - DCDHS - CYF DIVISION

Policy Analysis Statement:

Brief Description of Proposal -

Wisconsin Department of Children and Families has awarded "Trauma Project" monies in the amount \$10,000 to the Dane County Department of Human Services. These monies will be used to cover expenses related to training three cohorts of natural parents, foster parents, and Division staff in principles of Trauma-Informed-Parenting (TIP) in 2016-17. The training will consist of eight two-hour sessions for 20-25 participants in each cohort. Training is designed to increase caregivers' understanding of trauma reactions in children and youth. Increased stability of those children and youth in their placement situations is the ultimate goal.

Current Policy or Practice -

Budget and professional service contract changes require County Board approval.

Impact of Adopting Proposal -

The Department of Human Services accepts Wisconsin Department of Children and Families "Trauma Project" monies in amount \$10,000 and creates related revenue and expenditure lines. If the funds are not accepted Dane County will not provide training to parents, natural parents, and CYF Division staff as supported by these State monies.
