## LEG-ADV COMMITTEE RECOMMENDATION 091216

AAA Legislative/Advocacy Committee Chair Esther Olson stated that feedback from Senior Focal Point Directors indicated County Budget advocacy efforts are most important for three programs: Case Management, Volunteer Guardianship/Rep Payee, and Cultural Diversity. Therefore, the Legislative/Advocacy Committee felt it best to concentrate its advocacy efforts on those programs and not seek additional funding for the Special Project Fund in 2017.

Kusuda stated it is important to maintain the goal of obtaining Special Project Fund equal to five percent of total Case Management funding. By doing so, the Special Project Fund will be increased each budget period somewhat similar to the process called indexing.

KUSUDA moved, DOWNING seconded, to maintain the Special Project Fund as one of four Legislative/Advocacy Committee priorities in the 2017 Dane County Budget. The motion passed by the following vote:

6. FOSTER GRANDPARENT PROGRAM PROPOSED ELIMINATION

2016 FOSTER GRANDPARENT GRANT RELINQUISHMENT ACT-288 DOCUMENTS

RSVP of Dane County Executive Director Margie Zutter explained the impact of Wisconsin Department of Health Services' decision to relinquish its grant agreement with the Corporation for National and Community Service (CNCS) to operate the Foster Grandparent Program (FGP), effective 31 December 2016.

Zutter, as President of the Wisconsin Senior Corps Association, contacted Carrie Molke, Director of the Bureau of Aging and Disability Resources (BADR), to ask if the state would consider voiding its relinquishment and requesting a program extension from CNCS. Zutter also solicited input from BADR about how to best advocate for continuation of the program.

RSVP has as many as 15 low-income seniors work with at-risk children each year as part of FGP. Foster Grandparents receive \$2.65 per hour and mileage reimbursement, and are asked to work a minimum of 15 hours per week. RSVP receives \$56,000 per year to administer the program.

KUSUDA moved, DOWNING seconded, that the AAA Board write a letter to the Bureau of Aging & Disability Resources to request a one-year federal waiver to enable the state to review alternatives to meet federal requirements to enable Wisconsin to retain the Foster Grandparents Program that has helped so many for decades. The motion passed by the following vote:
