PP&J-C-3: Motion to Approve by Kigeya, seconded by Pellebon. Motion failed. 2-3 (Andrae, Kigeya, Pellebon) YGP 0-2

Motion to Deny by Eicher, seconded by Weigand. Motion passed. 3-2 (Kigeya, Pellebon) YGP 2-0

PP&J-C-2: Motion to approve by Andrae, Eicher seconded.

Motion to amend by Andrae by inserting the following language after the 4th paragraph: "Public access to any footage will be through the existing records request and in accordance with Wisconsin's Open Records Law." Eicher seconded. Motion passed unanimously.

Motion to amend by Eicher by deleting the following words in the fifth paragraph of the amendment: "18 months of the pilot start date" and replacing it with the following: "30 days of a change." Kigeya seconded. Motion passed unanimously.

Motion to amend by Eicher to delete the 2 sentences prior to the final sentence of the final paragraph, and replacing it with the following: "Input from the evaluation will be considered but may not influence future decisions on the body worn camera project." Pellebon seconded. Motion passed unanimously.

Motion to amend by Pellebon to delete the phrase "and other community members directly impacted by the pilot." and replaced it with the following: "individuals who are most directly impacted by the criminal legal system." Kigeya seconded.

Back to main motion to approve. Motion passed. Roll call vote: 5-0, YGP 2-0

PP&J-C-4: Motion by Weigand, Pellebon seconded.

Motion to amend by Pellebon by increasing the number of members from PPJ to two, and by adding the following language to the second paragraph: "Input from the subcommittee will be considered by PP&J but will not be binding on its funding decision." Motion passed unanimously.

Motion to amend by Weigand: deleting the word "Flock" from paragraph 1, reducing it to 4 citizen members and 3 must reside in municipalities, and including the following language: For 2025 capital expenses and beyond, there is created.... Kigeya seconded. Motion passed unanimously.

Back to main motion. Motion passed. Roll Call Vote 5-0, YGP 2-0

Discussion about amendment priorities ensued. Supervisor Eicher suggests the following order: PPJ O-4, O-5. Supervisor Pellebon suggests O-3, O-6. Supervisor Weigand suggests advancing the amendments with the lowest cost. Chair Andrae asks how she should prioritize O-1, and Supervisor Pellebon and Supervisor Eicher suggested that it should be a higher priority. Chair Andrae informed the committee that she will prioritize the amendments with the lowest dollar amendments, and then O-1 and O-4.
