APPROVING A SUB-LEASE FOR THE UW-EXTENSION FINANCIAL EDUCATION CENTER (FEC) AT THE VILLAGE ON PARK

Policy Analysis Statement:

Brief Description of Proposal -

WI Womens Business Initiative Corp (WWBIC) is now leasing the former space of the FEC. A WWBIC 3-year, 5-month lease has been negotiated with the City of Madison Community Development Authority. The FEC will sub-lease workstations in the WWBIC space along with access to certain common areas and office machines. The FEC can maintain a presence at the Villager at far less cost.

Current Policy or Practice -

Impact of Adopting Proposal -

The FEC's lease with Village on Park has ended. By sub-leasing workstations from WWBIC in the former space, the FEC will have a 75% reduction in costs. Funding for the FEC programs and staff are generated by donations and key programs and projected revenue is adequate. The former rent was 949.73/mo, and the new rate is \$211.00/mo, resulting in a savings each month of \$738.73 in 2015.
