Marino, Chance and Ozanne presented on the Community Restorative Court (CRC). A copy of the presentation is attached to these minutes. Krause asked about the Fitchburg data contained in the presentation, and Marino explained. Andrae asked about the methods that CRC used to notify individuals and if there were ways to support this. Marino provided information on how notifications work. Andrae asked how CRC handled specific questions, including drug and weapon possession. Marino and Ozanne provided CRC's policies. Joers wondered about Middleton's numbers under the program and Marino provided information. Bayrd asked if CRC attempted to meet individuals in person if they were non-responsive, and Marino explained that they did not typically do so. Bayrd asked about the decision process behind questioning why it was developed in the manner that it did. Marino provided information regarding the intake process. Andrae asked about the retail theft policy, and Ozanne explained. Andrae asked if the number of referrals are what the DA believes is sufficient, and Ozanne answered that it depends on available resources.
