AUTHORIZING EXECUTION OF A LEASE OF AGRICULTURAL LAND AT THE DANE COUNTY REGIONAL AIRPORT

## **Policy Analysis Statement:**

#### Brief Description of Proposal -

The Dane County Regional Airport has negotiated a successor lease with Renk Seed Company involving four parcels of vacant land in the vicinity of the Dane County Regional Airport, totaling 203.81 acres. The lease covers five growing seasons, expiring December 31, 2020, and continues the requirement that soil erosion and nutrient runoff be minimized.

#### Current Policy or Practice -

Land which surrounds the airfield at Dane County Regional Airport is leased to Renk Seed Company for agricultural use to generate revenue. Specific plowing practices are used to minimize attractants to wildlife that may be hazardous to airport operations.

## Impact of Adopting Proposal -

Agricultural land on airport property will continue to generate revenue in a manner consistent with airfield and aircraft safety.
