Brief Description of Proposal -

Two Department of Human Services professional services contracts need adjusting now that actual 2013 revenues and expenses are known. DCDHS has sufficient 2013 revenues and sufficient 2013 under-spending to cover these adjustments. The ACS Division contract with Journey Mental Health Center, Inc., should be increased by \$25,222. This is the net result of five program increases and two program reductions. The ACS Division contract with Tellurian UCAN, Inc. for Care Center services should be increased by \$8,050.
