## E. Reports to Board

## 1. STATE & FEDERAL REPORT

*Velasquez reported the United States Senate Appropriations Committee approved a subcommittee recommendation to eliminate all funding (\$52.1 million) for the State Health Insurance Assistance Program (SHIP), a move that would halt SHIP counselors from providing assistance and support comparing coverage options, navigating complex Medicare benefits, appealing denials and applying for financial assistance. In 2015, Wisconsin SHIP counselors had more than 95,000 client contacts and conducted 2,600 outreach events. The U.S. House of Representatives' Labor, Health & Human Services Appropriations Committee has a pending vote to restore SHIP funding. Dane County uses SHIP funding for the EBS and Case Management programs.*

## 4. CHAIR & STAFF REPORTS

*Batterman reported the 2017 AAA Budget proposal has been submitted to the Dane County Department of Human Services (DCDHS). AAA staff members are prohibited for sharing budget information prior to Director Lynn Green releasing the full DCDHS budget in August.*

*Batterman reported Leilani Amundson joined AAA as an Elder Benefits Specialist on 5 July 2016. Amundson previously was employed by the Wisconsin Disability Determination Board.*

*Batterman reported Velasquez will receive a Best Practices Award recognizing the successful implementation of the My Meal-My Way program at the Wisconsin Aging Network Conference in September. The senior nutrition program, which allows diners to order off of a menu at three restaurant sites and pay by donation, is being replicated around the state.*
