The Wisconsin Department of Justice, Division of Law Enforcement Services, is making funding available for participation in a Safe Neighborhoods Project, Grant Number 2024-PW-01-19870; grant funding of \$34,849 is available 11/1/2025 through 6/30/2027.

Project Safe Neighborhoods is a nationwide program that supports law enforcement efforts to combat gun violence. Grant funding will provide for overtime expenses for commissioned law enforcement employees of the Dane County Narcotics Task Force, including travel and training expenses associated with the Safe Neighborhoods Project.
