FUNDING OF A VOLUNTARY GUN BUYBACK PROGRAM FOR THE DANE COUNTY SHERIFF'S OFFICE

Policy Analysis Statement:

Brief Description of Proposal -

The Sheriff's Office is partnering with the Madison Police Department to hold a voluntary Gun Buyback Event, tentatively scheduled for August 13, 2022, to allow citizens to safely surrender unwanted firearms for destruction and receive gift cards for gas or groceries in exchange. In order to implement and conduct the Gun Buyback Program, the Sheriff's Office is requesting approval to utilize ARP funds in the amount of \$50,000 for the program.

Current Policy or Practice -

The Sheriff's Office also seeks authorization to accept public/private monetary and in-kind donations to supplement county funding for this event and potentially fund future events.

Impact of Adopting Proposal -

Voluntary Gun buyback programs provide a safe legal means for citizens to dispose of unwanted firearms and prevent them from getting into the hands of someone who shouldn't have them. Although these programs may not have a direct impact on overall gun violence, it will reduce the number of firearms potentially accessible to children, youth and vulnerable individuals.
