AUTHORIZATION TO MAKE PAYMENTS TO U.S. FOODS FOR CONSOLIDATED FOOD SERVICE

Policy Analysis Statement:

Brief Description of Proposal -

The county spends approximately \$1.2 to \$1.5 million on food through its prime food vendor. The county has chosen a new food vendor that offers discounts based on order size and speed of payment. Normal county approval processes for invoice approvals make it difficult to secure these discounts. This resolution provides authorization for the Controller's Office to issue payments directly, following the normal invoice audit process.

Current Policy or Practice -

Payments are approved by the Personnel and Finance Committee and those over \$10,000 are approved by the County Board.

Impact of Adopting Proposal -

Payments would be made based on the authorization provided in this resolution to allow the county to maximize discount opportunities. This will help control the cost of food for meals prepared for the jail, Badger Prairie and the Juvenile Detention facility.
